ADDITIONAL FEES

HOME & SCHOOL:



All parents are members of our Home & School Association.

All volunteers or adults attending events are required to have fingerprint and Virtus compliance. An active Virtus certificate must be on file and in good standing in the school office. Volunteers must maintain an active Virtus certification by completing monthly bulletins.

Home and School Membership fee is included in the Registration Fee (includes class party fees).

All families are expected to volunteer a minimum of 30 hours per school year to the school/parish community.

At least one parent is required to attend all Home & School meetings each school year.

GRADUATION:

(8th Grade Only)

\$300.00 Annual Graduation Fee per student due at the time of registration

Graduation Fee is NON-REFUNDABLE

Includes Cap and Gown and graduation materials

ANNUAL FESTIVAL:

Families are required to participate in the Annual Festival by volunteering a minimum of 3 hours and:

Purchasing a Sponsorship Package at the Silver, Gold, or Platinum Level

OR

Selling a minimum amount of Festival raffle tickets as outlined by the Pastor.

ANNUAL GALA:

Families are required to participate in the Annual Gala initiative by:

Students participating in the production and purchasing a minimum of two adult dinner tickets

OR

Selling a minimum amount of Gala raffle tickets as outlined by the Pastor.

In addition to the above obligatory fees, other fees may be incurred, including but/not limited to: uniforms, lunch, After School Care, sport teams and their respective uniforms, field trips, yearbook, school pictures, special activity t-shirts, charity fundraisers and/or donations, etc.

REFERRAL CREDIT PROGRAM

Families that refer a new family to Blessed Trinity School will receive a \$500 credit applied to their FACTS if:

Referred family's student is accepted and enrolled in our school,

Completes all registration requirements,

Signs up for FACTS or pays tuition in full.

Credit shall be disbursed at the discretion of school within the first 3 months of school.

Credit amount shall be capped at the total amount of tuition owed to the school.

Credit cannot be applied to past/future years and is non-transferrable.

Credit will be applied to tuition only and shall not exceed remaining balance.
